Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The following were observed during the inspection:

A female Camel named "Alice" was observed having dried, caked fecal material covering the entire rear end, tail and both rear legs. The licensee stated that this was the first time this condition had been observed. The licensee stated that the attending veterinary had not been consulted over the condition of this Camel at the time of inspection. The licensee stated that sometime in December or January this Camel had been dewormed. In addition, the license stated that this Camel had been housed in a dry lot and only recently been turned out to green grass. The Camel performed a bowl movement during the inspection and a stream of loose, greenish looking fecal waste was observed on the ground.

A male Camel named "Randy" was observed to have a wound on the front and rear of the right front leg. The licensee stated that on May 20th. they found the right front leg of this Camel wedged between two bars on the feeder. The licensee had to cut the bar to free the right front leg. The licensee stated that iodine was applied once to the open wounds. The licensee stated that the attending veterinary had not been consulted over the condition of this Camel at the time of inspection. Flies were observed on the front wounded area that was now scabbed over. The open wound on the back of the leg was still open with a red, moist looking tissue still visible. The front wound was estimated to be 1 inch in width by 2 inches in length. The wound behind the right front leg was estimated to be 2 inches in diameter.

Daily observation is critical to the health and wellbeing of all animals at the premise. Adequate veterinary care includes

daily observation with assessment and recognition of any possible health problems, with these problems promptly reported to the attending veterinarian, so that appropriate diagnostics and any necessary treatment can occur in a timely manner in order to safeguard the animal's well-being. Daily observation and direct, timely, and frequent communication with the attending veterinarian is essential for the health and care of the animals. Lack of communication of ongoing problems might result in a delay of treatment if severity of the problem is not known by the veterinarian. The licensee must develop and maintain records of routine daily observations to ensure any animal with a health problem is treated promptly and appropriately. Failure to diagnose conditions or to follow up when the recorded treatment does not correct the issues can cause unnecessary discomfort, pain or distress to the animals. The licensee must conduct daily observations of all animals to assess their health and well-being. Direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian. Complete and accurate records are needed to ensure each animal's identity can be known with certainty and to facilitate the ability to trace dogs. The licensee must ensure that all official identification on each dog in their possession is recorded. Correct by 6/25/21.
