The licensee must establish a written program of veterinary care with the current attending veterinarian.

### 3.1(c)(1)(2)

#### HOUSING FACILITIES, GENERAL.

In the indoor housing facility, the whelping enclosures each have a child's plastic swimming pool used to contain the puppies. In the enclosure housing one Doberman and nine puppies, the swimming pool has been ripped apart. This damage has resulted in the plastic being torn into sharp points. The sharp points create an injury risk to the dogs. This damaged swimming pool needs to be replaced or altered in a manner so that it no longer poses an injury risk to the animals.

#### INDOOR HOUSING FACILITIES.

In the indoor housing facility, the enclosures are framed with wooden two by fours. On at least three enclosures, some of the wood has been excessively chewed by the dogs. This damage has caused the wood to no longer be impervious to moisture. The wood needs to be replaced or altered in a manner that makes it impervious to moisture.
