HOUSING FACILITIES, GENERAL.

All primary enclosures that housed the adult and un-weaned puppies had rust and corrosion. Several of the enclosures had corrosion that created jagged edges and sharp points, because of breakage causing holes in the flooring. The dogs legs could fit through the holes and become injured due to the jagged edges and sharp points. The rust and corrosion cannot be properly cleaned and sanitized which can then harbor disease.

In the primary enclosures wooden boards were provided to the dogs and puppies for a solid resting surface. The boards have green residue and the edges are splitting and splintering off. The surfaces cannot be properly cleaned or sanitized which can harbor disease.

The licensee shall ensure all housing facilities are constructed so that they are structurally sound, kept in good repair, and protect the animals from injuries.

The corrections should be made by July 7, 2015.

3.11(d)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Inside and outside the sheltered housing there was an abundance of flies. The licensee used fly bags and once full did not dispose of the bags creating a strong odor and allowed the life cycle of the flies to continue adding to the number of flies. Flies contaminate surfaces and spread disease affecting the well-being of the dogs. The licensee must have an effective pest control program to reduce the number of pests and promote health and well-being of the animals.

The corrections should be made by July 1, 2015.

3.11

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The self-feeders had green film on the interior surfaces that were in contact with the food. The food is at risk for contamination which could cause illness in the dogs. The licensee shall sanitize the feeders at least once every two weeks and more often if necessary.
