ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

(b)(2)

There were three dogs at the facility that required veterinary care.

An adult male Yorkshire Terrier ID # 89 had a gray thick discharge in both eyes. There was dried discharge and hair matted around his eyes and mouth. The dog's right ear was filled with black wax. During an examination in December of 2013 the licensee's attending veterinarian diagnosed the animal with severe dental tarter/disease rating him a 5 out of 5 in severity.

An adult male Yorkshire Terrier ID# 78 had matted, soiled hair surrounding his mouth. There was a dark brown substance covering his molar teeth. The dog was also examined in December of 2013 and the written examination form documents that the licensee's attending veterinarian diagnosed the animal with severe dental tarter/disease rating him a 5 out of 5 in severity.

An adult female Papillion ID 102 was observed with a wad of hair stuck between her lower front teeth. When asked to remove the animal for closer inspection the licensee pulled the hair out of the animal's teeth causing its gums to bleed. There was a dark brown substance covering her molar teeth. The dog was also examined in December of 2013 and the written examination form documents that the licensee's attending veterinarian diagnosed the animal with severe dental tarter/disease rating her a 5 out of 5 in severity. Additionally, the dog had an opening the size of a pencil eraser on the top of her left front foot that was draining thick pink fluid. The licensee pressed on the foot and expressed thick yellow discharge from the opening. The licensee was not aware of the issue nor was the animal receiving treatment.

Abnormal conditions such as those listed above indicate health concerns which may be painful for the animals. The licensee shall provide adequate and timely veterinary care for the animals at the facility. The licensee shall obtain a written diagnosis and treatment plan for these animals and provide care as prescribed. HOUSING FACILITIES, GENERAL.

(c) Surfaces(3)

The indoor portion of the sheltered building housing Bulldogs had a buildup of grime, hair and trash. One of the enclosures containing a female and her 3, three day old puppies had sections of soiled paper towel scattered across the floor. When asked the licensee stated that they were the paper towels she used to clean the puppies off with after birth and the dam had torn them apart. The enclosure had a red substance dried on the walls and dog door of the enclosure. All of the enclosures had thick brown grime and hair along their edges and corners. Adequate cleaning is an important aspect of animal husbandry and helps to prevent disease, odor, pests. Hard surfaces with which the dogs come in contact must be spot-cleaned daily and sanitized in accordance with Sec. 3.11(b) of this subpart to prevent accumulation of excreta and reduce disease hazards TO BE CORRECTED BY: 7/10/2014

PRIMARY ENCLOSURES.

(a) General requirements(2)(i)

There were at least two enclosures of the adult sheltered facility (site 2) that had sections of broken 1X1 inch coated wire flooring. The sharp metal points protruding from the floor may injure the dogs. The licensee shall repair or replace these areas and ensure that all primary enclosures are constructed and maintained so that they have no sharp points or edges.

PRIMARY ENCLOSURES.

(a) General requirements(2)(x)

A un-weaned puppy housed in the whelping facility was observed with its feet passing through the 1x1 inch openings of the floor. This could result in injury to the puppy's feet and legs or in the inability for it to learn a proper gait. The licensee shall provide enclosures with flooring that protects the animals feet and legs from injury, and that does not allow the animal's feet to pass through any openings in the floor.

Inspection Report

The outdoor portion of the sheltered building housing female Bulldogs and their puppies had an accumulation of feces. Some of the feces had dried. When asked, the licensee stated that area had not been cleaned for three days due to the holiday. Adequate cleaning is a crucial aspect of animal husbandry and helps to reduce disease hazards, odors and pests. The licensee shall remove excreta from the primary enclosures daily and from under primary enclosures as often as necessary.

The adult male Yorkshire Terrier ID 78 was dripping wet at the time of the inspection. The kennel staff was using a hose to wash down on the indoor portion of the facility. The animals in the facility were observed leaving their enclosures while the staff cleaned, however, they returned when she moved to the adjacent enclosure. Due to the water pressure, when the staff sprayed an enclosure it reflected off of the wash down into the adjacent enclosures, wetting the returning dogs such as the Yorkshire Terrier. Bacteria and disease can be spread when animals are soiled or wetted from water reflecting from the wash down area. When steam or water is used to clean the primary enclosure, whether by hosing, flushing, or other methods, dogs must be removed, unless the enclosure is large enough to ensure the animals would not be harmed, wetted, or distressed in the process.
