2.40(b)(2) DIRECT REPEAT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*An adult English Bulldog named "JD" ID # 00070976CF had an open lesion on her forehead with yellow discharge. The licensee had not observed the condition and the dog was not receiving treatment. Skin conditions with colored discharge can be the indication of an infection and may be painful to the animal. The licensee shall have the dog evaluated by a licensed veterinarian to obtain a written diagnosis and treatment plan. Follow up care should be provided as prescribed and recorded in the animal's health records. TO BE CORRECTED BY: 3/16/2016

**There were 5 un-weaned Pug puppies that were born on 2/11/2016. The cage card on the outside of the enclosure listed that the dam had given birth to 7 puppies and 3 of the puppies were noted to be deceased. While the licensee had not recorded the dates the puppies had died she stated that they were at least two weeks of age when they died. She described the puppies as being smaller in size than the rest of the litter but was unsure for the reason for death as, they were never evaluated by a veterinarian or provided additional care. One of the 5 remaining puppies was 1/2 the size of its litter mates and appeared lethargic and weak. It's litter mates chewed on its ears and repeatedly climbed over its body rolling the smaller puppy around while it remained motionless. When the inspector asked the licensee why there were 7 puppies listed on the cage card, 3 of which were marked as deceased and there were 5 puppies remaining, the licensee and staff explained that they "expected the small puppy to die soon". The licensee and staff were not providing any individualized or veterinary care to the puppy. The licensee shall provide adequate and timely veterinary care to all animals at the facility. The licensee was verbally instructed to contact a licensed veterinarian and provide emergency veterinary care to the puppy immediately. TO BE CORRECTED BY: 3/14/2016

Note: The licensee left during the inspection to take the puppy to the veterinarian and the inspector confirmed care was received.

*** On 3/2/2016 an adult English Bulldog named "Casper" was taken to the attending veterinarian for a lack of appetite. The veterinarian documented the animal as having a body condition score of a 3/9 and confirmed the dog was positive for whipworms. The licensee was instructed to provide Fenbendazole, clean, and feed a high protein diet. The licensee stated she provided Fenbendazole for 6 days, as well as feeding the dog raw hamburger on the 6th day. On the 7th day the dog was found dead with blood draining from its rectum. Upon further inspection it was

discovered that the licensee has been mixing her own Fenbendazole wormer by using a large tube of Safeguard Beef and Dairy Cattle paste wormer (100mg/g) and diluting it with tap water. The licensee had no formal instructions for adding water to the worming mixture and the attending veterinarian had not authorized its use. Mixing or diluting medications can alter their desired effect and potency. The licensee shall provide prescribed care as directed by the attending veterinarian by using appropriate medications in their desired formulation. TO BE CORRECTED

2.50(a)(1) REPEAT

TIME AND METHOD OF IDENTIFICATION.

There was a black Pug born on 7/24/2015 that did not have official identification. Proper identification of each animal is needed for record keeping and animal traceability. The licensee shall ensure each animal at the facility is officially identified.

3.6(a)(2)(3) REPEAT

PRIMARY ENCLOSURES.

Animals at the facility are not contained securely and repetitively escape from their enclosures. There was a large hole in the divider panel between two of the outdoor enclosures of the sheltered whelping facility. One of the English Bulldog puppies had passed through the opening into another enclosure. Animals that are not securely contained in their enclosure can escape, become entrapped or become injured. The licensee must ensure that the enclosures securely contain the dogs.

This inspection was conducted with the licensee. An exit briefing was conducted with the licensee on the day of the inspection and a 2nd exit briefing was conducted during the report delivery.
