ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

***In the ready to use medication storage area, there was a bottle of "Ivermectin" without a legibly printed expiration date. A bottle of "Ivermectin" with an illegible expiration date was also included on the inspection report for the May 11, 2015 inspection. The licensee must ensure that all medications for use in dogs are appropriately labeled with legible expiration dates so that medications are not used past their labeled expiration date. Medications that are expired and given to the animals may not produce the desired result. The licensee must ensure that all animals receive adequate veterinary care at all times.

3.1(c)(3) REPEAT

HOUSING FACILITIES, GENERAL.

(c) Surfaces (3) Cleaning.

***There were five, 5 week old puppies housed in an outdoor enclosure with several areas of excreta which were attracting flies and odors. According to the licensee, the enclosure had not been moved nor had the excreta been picked up since the puppies were first put into the enclosure approximately five days prior to inspection. The several areas of excreta and the odors and insects that they are attracting increase the risk of disease hazards. The licensee must ensure that floors made of grass or other similar material are raked or spot-cleaned with sufficient frequency to prevent or eliminate odors, insects, pests, or vermin.

3.4(a)(1)(3)

OUTDOOR HOUSING FACILITIES.

(a) Restrictions. (1) (iii)

***There were five, 5 week old puppies housed in an outdoor enclosure. The attending veterinarian has not approved the practice of housing young dogs in outdoor housing. The potential for stress and discomfort exists if puppies cannot tolerate outside temperatures for an extended period of time. The housing of sick, infirm, aged or young dogs in outdoor housing facilities must be specifically approved by the attending veterinarian. The approval must be specific and list the ages and breeds of dogs that can be housed outdoors as well as indicate the temperature ranges which they may tolerate.
