Sec. 3.1 Housing facilities, general. (f) Drainage and waste disposal.

**** There are three pens that have standing water in them. The dogs in the pens legs and paws have become soiled from the mud. The covering the dogs fur will impact their ability to properly regulate their body temperature. The standing water in the pen also becomes a habitat for pest that will impact the health and well being of the dogs. The pens must have more gravel added to them to ensure proper drainage and waste removal and keep the dogs from becoming soiled.

OUTDOOR HOUSING FACILITIES.

Sec. 3.4 Outdoor housing facilities. (b) Shelter from the elements. (3)

**** There are ten dog houses, used for approximately 11 dogs, that are missing their wind/rain break on the entrances. The openings missing the wind/rain breaks allow the rain/ snow/ wind into the dog houses. This will expose the dogs to the weather and impact their well being. All dog houses must have wind/rain breaks on the entrances to protect the dogs from the weather.

**** Three pens using the 2 by 4 inch horse panels have sharp points by their doors. These sharp points can injure the dogs.

**** Two pens have sheets of tin lining the pen, these tins have sharp edges on the ends. These sharp edges can

**** There are three water bowls belonging to four dogs that had something growing inside the bowl along the bottom and sides that had a green appearance. This growth contaminates the water and no longer makes its potable and safe for the dogs to drink. Need to clean the water bowls and provide clean potable water for the dogs.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Sec. 3.11 Cleaning, sanitization, housekeeping, and pest control. (a) Cleaning of primary enclosures.

**** There are six dog houses housing 9 dogs that are dirty and muddy in appearance. The dirty dog houses allow the dogs to become soiled and attract pest. The dog houses must be cleaned to ensure that the dogs do not become soiled from dirt, fecal matter and reduce disease hazards, pests, insects and odors.

**** Three dog houses for 4 dogs have excessive dirt and debris inside the dog house flooring. This dirt and debris soils the dogs and hinder the health and well being. All surfaces that the dogs have contact with must be cleaned daily and sanitized at a minimum of every two weeks.

Sec. 3.11 Cleaning, sanitization, housekeeping, and pest control. (d) Pest control.

**** There is an over abundant level of flies present in the out door pens. The present of this many flies will introduce disease hazards to the dogs. A more stringent fly control to the facility, to reduce the number of flies in the facility, must be used.
