PRIMARY ENCLOSURES.

An adult female Poodle named Posey was lying on her side in an enclosure with three other adult dogs. She did not move her legs or appear able to rise. When the licensee attempted to pick her up she appeared painful and snapped at the licensee who had to wrap her in a towel to be able to pick her up. Even when she was removed from the enclosure, the dog made no effort to stand or use her legs. There was blood covering the back half of her body and what appeared to be bite wounds on her legs and back. Dogs may be injured when housed with more dominant or aggressive dogs. The licensee must ensure that dogs housed together in the same enclosure are compatible.

3.11(a) REPEAT

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Cleaning of primary enclosures.

****There was a strong odor of urine and feces in the whelping area located in the red building. Most of the catch-pans under the dog enclosures with grill-type floors contained a lot of urine and feces. The feces under one pen was dried and was covered in hair, indicating that the pan had not been emptied and cleaned for quite a while.

****Many of the outdoor portions of the sheltered facilities had an excessive amount of feces on the concrete flooring. Two of these enclosures had so much feces that the dogs could not avoid stepping in the feces and had fecal matter on their feet.

****During the inspection, the licensee sprayed water with a hose into an enclosure to clean the flooring. The spray from the hose wetted the dogs inside the enclosure.

Excessive feces and urine can be a disease hazard, can cause odors, and can attract insects and other pests. The licensee must clean the primary enclosures and the pans underneath them as often as necessary to prevent an accumulation of excessive waste. When cleaning the enclosures the licensee must ensure that the dogs are not wetted in the process.
