3.1(f)

Housing facilities, general.

Within one of the dog buildings, where dogs were housed, there was a trash container, containing trash without a lid. The lid was discovered within the building on the other side of a elevated dog enclosure. Trash containers in housing facilities and in food storage and food preparation areas must be leakproof and must have tightly fitted lids on them at all times. Corrected at time of the inspection: September 30, 2025.

3.6(a)(2)(ii)

Primary enclosures.

An adult female dog was housed inside one of the dog buildings, where her primary enclosure was considered the interior area of the building, the open entry area where elevated whelping enclosures were located and the hall running the length of the building between the other primary enclosures. Most of which contained dogs. Within this area were several electrical devices, located on the floor, (i.e. a heater) with electrical cords exposed. Items were stored on shelves within reach of the dog, which could fall onto the dog. There was a trash container within the area considered the primary enclosure of the dog with no lid. Primary enclosures must protect dogs from injury. Dogs must be housed within a primary enclosure that protects them from injury. To be corrected by October 14, 2025.

3.7(c)

Compatible grouping.

An adult female dog with new born puppies was housed within the same primary enclosure as another adult female dog. Puppies four months or less may not be housed in the same primary enclosure with adult dogs other than their dam. Housing young puppies with an adult dog that is not their dam can lead to injury or death. The adult dog that is not the dam must be housed in a different primary enclosure. Inspection Report

During the routine inspection for records it was noted that 57 of the 149 adult dogs were past due on their annual parvovirus and distemper vaccination. The dogs ranged from days to months overdue. According to the program of veterinary care all adult dogs must be vaccinated for parvovirus and distemper annually. Not following the written program of veterinary care and not maintaining dogs current on required vaccinations can lead to disease and death. The licensee must follow their program of veterinary care.
