ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

***A male King Charles Cavalier (104-625-525) had long hair with large sections of matted fur on the dog's ears. These matts had a brownish-black dried material mixed in the fur. Matting can be uncomfortable and can increase the risk of skin sores. The licensee must ensure this dog is groomed and establish an appropriate grooming schedule for all dogs.

This dog also had excessively long toenails. Excessive long nails can potentially cause pain and distress and can be an injury hazard should they get caught in the flooring. The licensee must trim the toenails. The toenails were addressed at the time of inspection. A program of toenail maintenance must be established to prevent long toenails. This dog was observed excessively scratching and rubbing against the wire divider. Along the back of the dog there was areas of missing hair and penny sized raised- reddened spots. There was areas of slight scabbing in the area missing fur. These sores could be the result of an injury, infection, or other veterinary medical condition which may be painful.

A male shih-tzu (020-353-084) had a lesion on the left shoulder. This lesion was about 2 inches long, with a black material caked next to the edge of the lesion, brownish-red material flaking in immediate area, and a dried greenish material in the lesion. This lesion could be the result of an injury, infection, or other veterinary medical condition which may be painful.

The licensee must consult with a licensed veterinarian regarding these animals conditions in order to ensure that an appropriate treatment plan is developed and followed. The licensee must ensure that all animals receive adequate veterinary care at all times.

and grime on doors and doorway walls. The doorways are approximately 50% -70% covered in grime. A build-up of grime on the doors is a disease hazard and can attract pests.

Cleanliness is important to the health and well-being of the animals. The licensee must ensure that enclosures are spot cleaned daily and sanitized at least every 2 weeks or more often if necessary to prevent an accumulation of dirt and grime and other disease hazards.
