There were 7 weaned puppies that did not have identification. Puppies should be individually identified when separated from their dam in order to ensure accurate records can be kept for each animal. 3.4 Outdoor housing facilities(b) Shelter from the elements(4)

There were 4 wooden dog shelters in the outdoor housing area that did not have adequate bedding. The temperature at the time of the inspection was 17 degrees F and the shelters did not have enough straw bedding to cover the floor inside the shelter. Adequate bedding is necessary to insulate the dogs from the cold temperatures and helps them to retain their body heat. The licensee shall ensure that all of the outdoor shelters contain clean, dry, bedding material if the ambient temperature is below 50 degrees F and additional clean, dry bedding is required when the temperature is 35 degrees F or lower.
