(2) The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care;

* A Shetland Sheep dog (no identification) "Tippy", has clumped, matted hair along the back, neck and dangling off his ear. Matted hair can pull on the skin, trap moisture, cause skin irritation and pain. Licensee must remove all matts from the dog, establish and maintain an effective grooming protocol to prevent and remove matts as they may occur for the health of the dog.

TIME AND METHOD OF IDENTIFICATION.

(1) All live dogs and cats held on the premises, purchased, or otherwise acquired, sold or otherwise disposed of, or removed from the premises for delivery to a research facility or exhibitor or to another dealer, or for sale, through an auction sale or to any person for use as a pet, shall be identified by an official tag of the type described in Sec. 2.51

* "Tippy" a Shetland Sheep dog did not have individual identification. Three female dogs with litters of puppies did not have individual identification. Unique individual identification is required to allow for individual identification of each animal on the premise for tracking/ identification purposes. Licensee must ensure that all dogs are physically identified with a unique individual number as described in Sec. 2.51 to allow for accurate identification.

* Twenty unweaned puppies maintained in three separate litters with the dam were not identified. Cage cards with appropriate/required information were not present nor were the dams identified. Licensee must ensure that all puppies are identified through official tags, collars, tattoos, cage cards or when maintained as an unweaned litter with the dam that the dam is individually identified.

HOUSING FACILITIES, GENERAL.

(a) Structure; construction.

* The barrel-type shelter structure currently being used to house two dogs is not stable. When the dogs enter the shelter, the barrel rolls from side to side. Licensee must repair or replace the housing structure so that it is stable and does not allow for movement when the dogs are contained within.

HOUSING FACILITIES, GENERAL.

(2) Maintenance and replacement of surfaces.

* The cement in two outdoor enclosures (containing 2 dogs total) has cracks approximately 1 inch wide. Fecal material and dirt were embedded in these cracks. Cracked/broken concrete cannot be cleaned and sanitized properly. Licensee must replace or repair these areas of cracked concrete to allow for proper cleaning and sanitization to occur to prevent disease hazards to the dogs.

(b) Shelter from the elements.

* Two Shetland Sheep dogs are in an outdoor enclosure and provided with a single plastic barrel-type shelter. The provided shelter is not large enough to accommodate all the animals in the enclosure at the same time and allow
