#### HOUSING FACILITIES, GENERAL.

The indoor portion of the Wheaton building had dog food, hair, and dirt along the edges of the enclosures. This debris had attracted ants that then entered the feeders. There was mold in several of the feeders in addition to the ants. The licensee must spot clean daily and sanitize in accordance with 3.11(b)(3)

### 3.1

#### HOUSING FACILITIES, GENERAL.

There was mouse bait and bleach container on the floor of the Wheaton building was accessible to loose animals in the facility. Toxic substances can cause skin irritations and internal problems if consumed. The licensee must store toxic substances in cabinets or where dogs cannot access them.

#### CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Under the first sheltered building with raised enclosures, there was an accumulation of feces on the gravel surface. This attracted flies that can spread disease and irritate the dogs skin and eyes. The licensee must remove excreta

### 3.11(c)

#### **CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.**

Around each of the facilities there were weeds and or grass growing up and into the enclosures. The Wheaton building had a rear enclosure that had wood surfaces that were not impervious to moisture, and areas with green and black coloration. In that same enclosure was a metal item with sharp corners that could cause injury to the animals. Soiled items, such as carpet pieces, were placed outside and not disposed of properly. These conditions cause areas for rodents, and other pests and vermin. The licensee must keep premises clean and in good repair to include removal of trash, junk, waste products and other discarded matter. Weeds, grasses, and bushes must be controlled.

### 3.11(d)

#### **CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.**

Flies were abundant inside and outside of the sheltered facilities. Flies spread disease and can irritate the dogs skin and eyes. The licensee must establish and maintain an effective program for the control of insects to promote the health and well-being of the animals and reduce contamination by pests in animal areas.

TO BE CORRECTED BY JULY 2, 2015

Ants were in every kennel in the converted dairy barn and had entered the feeders. Ants spread disease and can make the food unpalatable for the dogs. The licensee must establish and maintain an effective program for the control of insects to promote the health and well-being of the animals and reduce contamination by pests in animal areas.
