Attending veterinarian and adequate veterinary care (dealers and exhibitors).

A male Bichon's (#021) left eye had some tear staining. Upon closer observation there was a very small lesion on the upper eyelid. This lesion was approximately 1mm and the skin in the lesion was reddened. The small lesion could irritate the eye causing discomfort to the dog. The licensee must consult with a veterinarian and develop and document a treatment plan.

3.1(f)

Housing facilities, general.

The waste drainage pipe for the kennel was broke and leaking next to the building. The broke waste drainage pipe outside are close to the building and food and feces are accumulating on the ground. Having waste close to the facility can attract pest and vermin that can harm the dogs. The waste disposal system must dispose the waste far enough from the facility as to not attract pests or vermin near the animals.

3.13(a)

Veterinary care for dogs.

The program of veterinary care was missing the frequency of the kennel visit and exam of each dog. It is important to have the attending veterinarian visit the kennel and exam the dogs to ensure dogs are meeting the veterinary

requirements. The licensee must develop and document a veterinary approved program of veterinary care that includes kennel visits , not more than every 12 months and exams for each kennel dog.

3.13(a)(3)

Veterinary care for dogs.

The program of veterinary care had not been updated with the changes of vaccination and deworming schedule. The program of veterinary care was also missing the parasite sampling/testing. It is important for the dogs health to follow instructions by your veterinarian. The licensee must document a current program of veterinary care approved by the attending veterinarian.

3.13(a)(4)

Veterinary care for dogs.

The program of veterinary care was missing the preventative care section. The licensee did not have the preventative care and treatment plan to ensure healthy and unmatted hair coats, properly trimmed nails, and clean and healthy eyes, ears, skin, and teeth, which are important to the dogs health. The licensee must develop and document a plan.

This is a 1st Re-License Inspection for a Class A license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by 23 Nov 2021 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.

Regulated activity can continue under your existing USDA license until it expires.
