ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

* There was an adult marmoset which had nearly complete hairloss on the top half of its tail and noticeable hairloss on its hind legs. The animal's haircoat looked unthrifty in general and areas of yellow crustiness could be seen in the animal's hair in different spots throughout the coat. There were small clumps of hair that could be seen hanging from the animal's coat and on its cloth resting pouch. Several times the animal was observed scratching itself excessively. The licensee stated that the animal had also been losing weight. This animal had not yet been examined by a veterinarian. The licensee stated he spoke to his vet about the condition but had no documentation of any consultation and the animal wasn't under any type of treatment plan.

** This animal could have a medical condition or a parasite which could be harmful to it and possibly to the other animals in the facility.

*** The licensee must have this animal examined by a veterinarian to obtain an accurate diagnosis and appropriate treatment plan. The licensee must ensure that all animals receive adequate veterinary care at all times. TO BE CORRECTED BY: 12 May 2014.

* There were two baby capuchins observed during the inspection. One was approximately 3 weeks old and the other was approximately 5 weeks old, according to the licensee. The licensee stated they were both born at the facility but had no documentation showing that the animals were present at the facility.

** Complete and accurate records must be kept in order to ensure that each animal's identity can be known with certainty and to facilitate tracking/tracing of animals.

*** The licensee must make, keep, and maintain accurate records for all animals at the facility, including any offspring born of any animal while in the licensee's possession. TO BE CORRECTED BY: 16 May 2014.
