HOUSING FACILITIES, GENERAL.

****In the quarantine room, under several enclosures, near where fecal material was found on the floor, there was a spotted, slimy, black, mold-like substance on the floor in multiple areas. According to a facility representative, a bleach-water is sprayed over the feces daily, prior to rinsing the floor with regular water but no further sanitizing is done to the floor areas on a regular basis. Although not directly in contact with the animals, all the surfaces in this room need to be cleaned and sanitized to help prevent disease transmission. The licensee must ensure that surfaces of housing facilities which do not come in contact with the animals are cleaned and sanitized when necessary to satisfy generally accepted husbandry standards and practices.

ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

(c) Special considerations.

****There was an adult, female rhesus macaque (#32471) with approximately 90% hair loss on her chest, abdomen, legs, and arms. A medical record showed the hair loss was first observed on 2 June 2014 but was only on the legs and arms. The veterinarian recommended additional enrichment but it is unclear from documentation whether or not it was provided. The only other documentation in the animal's record about the hair loss was entered on 1 July 2014 and stated "TV set at end of day animal seems to be doing better". At the time of inspection, the animal did not appear to have any additional enrichment compared to all the other monkeys in the facility. This is not adequate attention or enrichment for an animal with such excessive hair loss. Hair loss can be a sign that the animal is in psychological distress. Failure to implement a special plan regarding environmental enhancement in animals showing signs of psychological distress can lead to further psychological distress or animal self-injury. The licensee must develop, document, and follow an environmental enhancement plan that specifically addresses animals showing signs of being in psychological distress through behavior or appearance (hair loss).
