Attending veterinarian and adequate veterinary care (dealers and exhibitors).

Three medications were past their expiration dates. These medications were in the storage area with the rest of the medications. Tylan 50 expired June of 2018; Gentamicin sulfate expired March of 2021; and 50% Dextrose expired November of 2020. Expired medications may have lost their efficacy and ability to provide appropriate prevention or treatment of medical problems. The licensee must ensure that all medications are within their expiration dates.

Time and method of identification.

Three puppies (one Pyrenees and two Cocker spaniels) less than 16 weeks old did not have any type of individual identification. Appropriate identification of dogs is necessary to meet recordkeeping requirements for inventory, disposition, transport, and healthcare documentation. The licensee must properly identify each puppy with a microchip, tattoo, or collar.

Inspection Report

Seven puppies in the holding facility did not have adequate floor space.

*A female Pyrenees puppy (#111-21) that was 20 inches long from the tip of its nose to the base of its tail and a female Pyrenees puppy (no ID) that was 21 inches long were housed together in pen #20. They required 9.75 square feet of floor space, but they only had 4.0 square feet of space.

*A female Pyrenees puppy (#107-21) in pen #19 was 20 inches long. She required 4.69 square feet of floor space, but only had 4.0 square feet of space.

*A male Pyrenees puppy (#103-21) that was 21 inches long and a female Pyrenees puppy (#110-21) that was 21 inches long were housed together in pen #38. They required a total of 10.12 square feet of floor space, but only had 4.0 square feet of space.

*A male Cocker spaniel puppy (no ID) that was 16 inches long and a female Cocker spaniel puppy (no ID) that was 16 inches long were housed together in pen #9. They required 6.72 square feet of floor space, but only had 3.5 square feet of space.

Adequate floor space is necessary to allow normal postural movements for the well-being and comfort of the dogs. The licensee must ensure that each dog has adequate floor space when in the holding facility.

3.6(c)(1)(iii)

Primary enclosures.

Seven puppies in a total of four enclosures (pens #9, 19, 20, and 38) in the holding facility only had 1-4 inches of head space. Adequate head space is necessary to provide enough room for the puppies to comfortably make natural postural movements. The licensee must ensure that the interior height of each primary enclosure is at least 6 inches higher than
