* Some medications stored on hand were expired and one medication wasn't properly labeled;

- Neomycin/Polymyxin ointment expired 11/13.
- Nobivac Canine 1-DAPPv+L expired 19 Feb 2016.
- Unlabeled medication with expiration date of 2/17 (the contents were unknown to the license).

If used, expired medications may be less effective or may become toxic for animals. Medications must be properly labeled to ensure that they are given correctly to animals. For the health of animals, ensure that expired medications are properly disposed of and that all medications are properly labeled.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

* Seven rubber bowls are used to feed 14 adult dogs and four puppies. These feed receptacles had an accumulation of brown to grayish grime or debris and hair on their surfaces. This indicates that the feed receptacles are not being cleaned and sanitized often enough. As a result this can increase the disease potential for the dogs.

For the prevention of an accumulation of grime, debris and dog hair, all feed receptacles must be cleaned and sanitized more frequently. More frequent cleaning and sanitization will minimize the disease potential for the animals.
