TIME AND METHOD OF IDENTIFICATION.

An adult female fawn and white boxer named "Zoey" had no identification at the time of inspection. The representative stated the dog had just cleared its brucellosis test and been moved to the enclosure two days ago.

Official identification is required in order to facilitate the required record keeping and to ensure that each animal's identity can be known for certain.

The licensee must ensure that all dogs held on the premises, purchased, acquired, sold or disposed of be identified by methods described in Subpart E Identification of Animals Section 2.50, or by microchip.

2.50(a)(2)

TIME AND METHOD OF IDENTIFICATION.

In "Building #3" there are four weaned pups, a 12 week-old Siberian husky, and three 10 week-old English bulldogs with no identification.

Official identification is required in order to facilitate the required record keeping and to ensure that each animal 's identity can be known for certain.

The licensee must ensure that puppies less than 16 weeks of age be identified by an official tag affixed to a collar, a tattoo, a plastic type collar with the required information, or a microchip. If weaned puppies are maintained as a litter, it is also acceptable to use a cage card containing the puppies' individual identification numbers and identifying characteristics such as date of birth, breed, and sex.

3.1(c)(3) REPEAT

HOUSING FACILITIES, GENERAL.

The floor inside of "Building #3" has a lot of dead flies and some dog kibble scattered around. When asked by the inspector how often the floor gets cleaned, the representative stated that underneath the enclosures gets cleaned every day, but the floor between both sides of the enclosures gets swept about once a week.

A buildup of dirt, debris, and other organic material can cause odors, attract pests and other vermin which can spread disease and cause other health hazards.

The licensee must ensure that all surfaces of housing facilities be cleaned and sanitized as often as necessary to satisfy generally accepted husbandry practices.

3.6(a)(2)(2)

PRIMARY ENCLOSURES.

In two outdoor enclosures housing four dogs, there are exposed wire panels in holes dug by the dogs.

These exposed wires panels could cause the animals to get their foot or leg caught and result in injury.

The licensee must ensure that exposed wire panels or other hazards are repaired and maintained to protect the animals from injury.

To be corrected by August 1, 2014.

3.11(d)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

There are two dogs that have old, almost healed wounds on their ears. The representative stated they were from fly strikes and that they have been using an environmental fly control spray which had been successful until the past week after the temperatures rose.

Fly strikes are evidence of excessive flies on the premises.

The licensee must establish and maintain an effective program for the control of insects and other external parasites affecting the dogs to promote the health and well-being of the animals and to reduce contamination by pests in the
