There are five litters of puppies that do not have complete and accurate inventory records. Accurate and complete records are essential for the tracking of dogs and puppies in the kennel. There must be complete and accurate inventory records for all dogs and puppies in the kennel. Correct by 17 August 2015.

3.1(c)(1)

HOUSING FACILITIES, GENERAL.

The metal support pipes for the outdoor enclosures on the concrete and the metal support pipes for two of the outdoor portion of the elevated sheltered enclosures have peeling paint and roughened surfaces. Surfaces such as these cannot be readily cleaned and sanitized. All surfaces in contact with the dogs need to be constructed and maintained in a manner that allows them to be readily cleaned and sanitized. Correct by 24 August 2015.

3.11(a)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

One enclosure two housing shiba inus in the sheltered whelping building has an excess of feces in the outdoor portion of the enclosure. The feces line the sides of the enclosure and are dry and covered with hair. The facility representative stated that this enclosure was last spot cleaned to remove feces before the weekend. (The inspection day is Monday.) An excessive accumulation of feces can attract pests, contribute to odors, and play a role in disease transmission. The licensee must ensure that excreta and food wastes are removed from the primary enclosures daily and from under primary enclosures as often as necessary to prevent an excessive accumulation of feces and food waste. Correct by 11 August 2015.

The two dogs, female shiba inu (ID # 941000013052495) and male Chinese pug (ID # OAO1137624) cited on 8 May 2015 have been examined by the attending veterinarian.
