TIME AND METHOD OF IDENTIFICATION.

* There is an estimated 25 dogs that do not have official identification on them at time of facility inspection. The licensee is using tags as the official identification. The letters USDA, the facility USDA license number and individual identification numbers are missing on the tags. The licensee is hanging the tags for individual dogs on the enclosure fencing. Official identification is needed to ensure that each animal's identity can be known with certainty and to facilitate the inspection process. The licensee must ensure that all dogs on the premise have official identification on them at all times. Correct by 5/1/14.

3.1(c)(3)

HOUSING FACILITIES, GENERAL.

* There is a mixture of dirt, grease and other excreta accumulating on ten fiberglass wall boards. Sixteen dogs are in contact with the affected wall boards located in shelter housing. The affected area covers approximately 25 to 40 percent of the wall surface. Sanitization of surfaces is necessary to prevent an accumulation of excreta and other disease hazards. It indicates an unsanitary living condition exists that could lead to potential disease or health risks. The licensee must ensure that all surfaces are spot cleaned daily and sanitized in accordance with section 3.11 (b). Correct by 4/3/14.

EXERCISE FOR DOGS.

* No copy of the program of exercise for 50 dogs was made available at time of facility inspection. The program of exercise must be developed in accordance with the attending veterinarian recommendations to ensure the dogs are receiving adequate exercise. The licensee must develop, document and follow an appropriate plan of exercise and the plan must be approved by the attending veterinarian. Correct by 5/1/14.

* Facility inspection done on 4/1/14 and exit briefing conducted per phone conversation on 4/2/14 were conducted with the licensee.
