2.40(b)(3) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

* One white colored adult male Standard Poodle (microchip number 985121007730713) was visualized shaking its head during the facility inspection. Examination of the underside of the ear revealed a blackish looking substance was covering the underside of the ear. The tissue on the underside of the ear was moist, reddened and thickened in appearance. In addition, a foul odor coming from the ear was detected by the inspector. The licensee stated they first noticed the condition on 12/29/15. The attending veterinarian had not been consulted nor had any treatment been provided at the time of inspection. The licensee did call the attending veterinarian during the facility inspection. Head shaking and thickened tissue in the ears may indicate infection, parasites, or chronic inflammation which can cause discomfort, pain, and possible hearing loss if left untreated. The licensee must have this animal examined by a veterinarian and appropriate treatment plan administered. The outcome of this examination must be documented and provided to the inspector upon request. The licensee must ensure that all animals receive adequate veterinary care at all times. To be corrected by the end of business 1/5/2016.

3.1(c)(1)(2) REPEAT

HOUSING FACILITIES, GENERAL.

* One sheet of tin attached to the divider fencing in one outdoor enclosure has an estimated three inch tear along the lower left hand corner. The metal was turned inwards towards the dog. One dog is in contact with the affected tin. Jagged edges with sharp points could cause potential injury. The licensee must ensure all surfaces are free of any jagged edges or sharp points that might injure the animals.

3.1(c)(3) REPEAT

HOUSING FACILITIES, GENERAL.

* There is a mixture of dirt, grease and other excreta collecting on the exterior fiberglass wallboard in at least eight enclosures. Twelve dogs are in contact with the affected surfaces located in sheltered housing. Dirt, grease and other excreta is covering an estimated 25 to 30 percent of the fiberglass wallboard area. Daily cleaning of any surface that comes in contact with the dogs is necessary to prevent an accumulation of excreta and help to reduce

disease hazards. This indicates an unsanitary living condition exists that could lead to potential disease or health risks. The licensee must ensure that all surfaces are spot cleaned on a daily basis and sanitized in accordance with 3.11 (b).

3.9(b) REPEAT

FEEDING.

* A brownish looking greasy substance was covering the interior surface area of at least three plastic self-feeders used by three dogs. In addition, caked, molded feed was observed collecting on the interior metal rim of at least three plastic self-feeders used by three dogs. It indicates a lack of cleaning is occurring on the interior of the food receptacle. Food receptacles not being kept clean could harbor bacteria and other disease causing agents which affects the health of the dogs. The nutritive value of the feed being fed could be affected if it becomes spoiled or contaminated. The licensee must ensure measures are taken so there is no molding, deterioration, or caking of feed that is offered to the dogs. The licensee must ensure all food receptacles are kept clean and must be sanitized in accordance with 3.11 (b).

* The facility inspection and verbal exit briefing done on 12/30/15 were conducted with the licensee.

* The exit briefing done on 1/5/16 was conducted with the licensee.
