HOUSING FACILITIES, GENERAL.

Surfaces that cannot be cleaned and sanitized must be replaced when worn, chewed, or soiled. The wood frames of the doggy entrance to the whelping part of the enclosure are much chewed, with parts of the screw heads starting to protrude. This raw chewed wood cannot be cleaned or sanitized. Surfaces must be able to be properly cleaned and then sanitized to help prevent diseases and maintain a healthy environment for dogs. The owner needs to put into place a good maintenance program that closely monitors and repairs surfaces before they become a problem and a hazard for dogs. The owner must repair or replace these chewed surfaces, in order for proper cleaning and sanitization to take place. Correct by 10-01-2015

HOUSING FACILITIES, GENERAL.

Housing facilities must have access to reliable electric power for heating, cooling, ventilation, lighting, and for carrying out other requirements per the Animal Welfare Act (AWA) regulations. This facility has no means of electric power. The owner must put into place and maintain the availability for access to a form of electricity to be used as needed to help ensure the good health of the dogs in this facility and to maintain husbandry standards. Correct by 10-01-2015.

PRIMARY ENCLOSURES.

All surfaces in contact with dogs must be readily available to be cleaned, sanitized, and/or be repaired or replaced when worn. Two outside runs of the Whelping building, west side and east side respectfully, have cracks in the concrete flooring that are allowing feces, dirt, and other debris to be lodged. Also, at least one of the concrete runs in the outdoor housing have cracks that are allowing feces, dirt, and other debris to be lodged. These cracks cannot and are not being adequately cleaned and sanitized. The owner must repair these areas of the concrete flooring in order for good cleaning and sanitization to take place. Correct by 10-01-2015
