OUTDOOR HOUSING FACILITIES.

One of the outdoor shelter structures for three dogs housed in the outdoor enclosure since yesterday does not have adequate wind and rain break at the entrance. Failure to provide a barrier from the elements in the form of a wind and rain break can result in a dog that becomes wet and uncomfortable. In some weather, a dog that does not have a barrier from the elements is unable to maintain a safe body temperature. All dogs must be provided with shelter from the elements which includes wind and rain breaks at the entrance to shelter structures. This was corrected at the time of inspection when the dogs were removed from an outdoor enclosure.

3.4(b)(4) DIRECT

OUTDOOR HOUSING FACILITIES.

There is no bedding in the shelter structures provided to three dogs that have been housed in an outdoor enclosure since yesterday. The ambient temperature recorded on the inspector's Kestral during the inspection was 37.4 degrees F. When the licensee's zip code was entered into the weather.gov website, the lowest temperature recorded for last night was 32 degrees F. Lack of bedding in cold weather can result in dogs that cannot maintain a safe body temperature. The licensee must provide clean, dry bedding material in the ambient temperature is below 50 degrees F and additional bedding when the temperature is below 35 degrees F. These dogs were moved to a sheltered enclosure during the inspection. To be corrected from this point forward.

3.6(a)(2)(9)

PRIMARY ENCLOSURES.

One enclosure housing a female and her puppies had carpet square heavily soiled with excreta provided as bedding. This carpet square was directly in front of the food and water receptacles. Soiled surfaces that come into contact with the dogs can play a role in disease transmission and can cause the animals to become soiled. The licensee must ensure that all surfaces in contact with the dogs and cats be readily cleaned and sanitized in accordance with Sec. 3.11(b) of this subpart, or be replaceable when worn or soiled. To be corrected by 7 January 2016.
