ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Adult, female Lhasa Apso with chip number 042 862 378 has a very thick accumulation of dental calculus on all of the upper molar and premolar teeth. All of the premolar teeth are totally obscured by the thick calculus. The gum line over the upper premolar teeth of both sides is recessed up from normal and is red on the right side. Dental disease can cause damage to the gum tissue and tooth and mouth structures, be painful, and impact the ability of the dog to eat normally, affecting the overall health of the animal. The animal listed above must be examined by a licensed veterinarian by the end of business on 11 August 2016 in order to ensure that an accurate diagnosis is obtained and an appropriate treatment plan is developed and followed. This information, including the diagnosis, treatment and resolution of the condition, must be documented and made available to the inspector upon request.

RECORDS: DEALERS AND EXHIBITORS.

There is one Keeshond being housed in the long kennel building that is on the premises temporarily. This dog is not accounted for on the APHIS 7005 form (Dogs on Hand Form).

There are receipts for 2 dogs showing that the licensee shipped them via a commercial shipping company but the licensee does not have APHIS 7006 forms (Disposition Form) showing their disposition.

Proper record keeping is essential for tracking the movement of animals and to facilitate the inspection process. The licensee must make, keep, and maintain records or forms which fully and correctly disclose the full and correct information required concerning each dog or cat purchased or otherwise acquired, owned, held, or otherwise in his or her possession or under his or her control, or which is transported, euthanized, sold, or otherwise disposed of by that dealer or exhibitor. To be corrected by 15 August 2016.
