ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Male, red Australian Cattle dog (965000000385210) has scabs and hair loss on the ends of the ear flaps. The scabs cover about a half of the top of the left ear flap and less than a quarter of the right ear flap. An occasional fly was seen on the ears of this dog during the inspection.

Female, blue Australian Cattle dog (965000000381049) has scabs and hair loss on the end of the left ear flap. The scabs cover about a quarter of the top of the left ear flap. Many flies at one time were seen on the ears of this dog during the inspection.

Male, fawn boxer (053 787 095) has mild scabs and mild hair loss at the front edge of the base of both ears. Excessive flies were seen on the ears as well as the back and rear legs of this dog.

Flies and fly bites cause irritation to the skin of dogs which can go on to be infected. Flies are irritating to the dogs and the resulting skin problems can be painful. The licensee must have these animals examined by a licensed veterinarian by close of business 11 June 2016 in order to ensure that an accurate diagnosis is obtained and that an appropriate treatment plan and plan for ongoing fly control is developed and followed. The licensee must document the outcome of this consultation and make it available to the inspector upon request.

3.4(b)

OUTDOOR HOUSING FACILITIES.

One enclosure in use for two dogs does not have adequate areas of shade. The material in use will not provide shade throughout the day. Lack of shade may cause dogs to overheat and create discomfort for the dogs. Dogs in all outdoor enclosures must be provided with areas of shade at all times. Correct by 11 June 2016.

WATERING.

At the time of the inspection (10:15AM) the water receptacle for two dogs was dry. The facility representative provided water for these dogs while the inspectors were present. The dogs drank off and on for one minute as

timed by the inspector's watch. Lack of water may cause the dogs to dehydrate and overheat. All dogs must be provided with water as often as necessary to ensure their health and well-being. Corrected at the time of the inspection.

3.11(b)(2)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

At least two of the water receptacles are green with algae along with some debris on the bottom and insects floating on the top. Dirty water receptacles may cause the dogs to be reluctant from drinking. All water receptacles must be kept clean and sanitized. Correct by 11 June 2016.

3.11(c)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Weeds and grass have grown-up to be 2-3 feet tall around the perimeter of the dog enclosures. Uncontrolled vegetation may harbor vermin and pests. All weeds and grass must be controlled. Correct by 15 June 2016.

3.11(d)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Flies were observed around many of the enclosures and on several dogs in both the outdoor as well as the indoor housing facilities. Some of the dogs were observed snapping at the flies, shaking their heads and taking protection in their shelters. Flies can transmit diseases, cause distress to the dogs, and create trauma to the dogs. A better method of fly control must be established and maintained. Correct by 11 June 2016.
