3.1(c)(1)(ii)

HOUSING FACILITIES, GENERAL.

There is an area of welded wire panel in the outdoor portion of the sheltered large dog building that is turned up resulting in exposed sharp points.

There are areas of deteriorating metal lining the enclosure wall resulting in jagged metal edges in two outdoor portions of sheltered buildings.

Jagged edges and sharp points can injure dogs in the enclosures. The licensee must ensure that the surfaces of all housing facilities in contact with dogs be free of jagged edges or sharp points that might injure the animals. To be corrected by 1 Feb 2020.

3.1(c)(2)

HOUSING FACILITIES, GENERAL.

There are three enclosures in the small dog sheltered building with wood that has been chewed resulting in a rough, unfinished surface.

There is one enclosure in the small dog sheltered building with cracked vinyl flooring with the edges pulling away from the underlying structure.

There is one enclosure in the large dog sheltered building with exposed unfinished wood where the outer layer of finished board has been chewed.

Surfaces that are not maintained so that they are able to be readily cleaned and sanitized can contribute to the spread of diseases. The licensee must ensure that surfaces of housing facilities must be constructed in a manner and made of materials that allow them to be readily cleaned and sanitized, or removed or replaced when worn or soiled. 3.3(a)

SHELTERED HOUSING FACILITIES.

The ambient temperature in the indoor portion of the large dog sheltered building was 45.2 degrees F according to the inspector's Kestrel thermometer. The ten dogs housed in this building do not have bedding or resting surfaces

on the cement floors of the enclosures. Lack of resting surfaces in the cold can result in a dog that is uncomfortable. The licensee must ensure that dry bedding, solid resting boards, or other methods of conserving body heat must be provided to the dogs when temperatures are below 50 degrees F in the sheltered housing. To be corrected by 15 January 2020 when the temperature in the sheltered building is below 50 degrees F.
