Records: Dealers and exhibitors.

The facility has 20 domestic cats but the acquisition information for only 1 cat is recorded on APHIS Form 7005 (Record of Acquisition of Dogs and Cats on Hand). APHIS Form 7005 must be used in order to ensure all required acquisition information is documented and available for the APHIS inspector.

Each dealer shall use APHIS Form 7005 to make, keep, and maintain required acquisition information. The licensee must add the acquisition information for the remaining 19 domestic cats to APHIS Form 7005 and ensure that the form is kept updated and available for inspection.

The facility has not been using APHIS Form 7006 (Record of Disposition of Dogs and Cats) to document the sale of the kittens. APHIS Form 7006 must be used in order to ensure that all required disposition information is documented and available for inspection.

Each dealer shall use APHIS Form 7006 (Record of Disposition of Dogs and Cats) to make, keep, and maintain the required disposition information. The licensee must use APHIS Form 7006 to record the disposition (sale, donation, or trade) of all adult cats and kittens and ensure these records are available for inspection.

3.1(e)

Housing facilities, general.

There are 5 bags of unopened cat food stored on the floor of the housing facility. Bags of food stored directly on the floor could become spoiled or contaminated should they come into contact with spilled water. Bags stored on the floor can also interfere with cleaning of the facility which could attract pests such as insects and rodents.

Unopened bags of food must be stored off the floor and away from walls to allow for cleaning and to protect the food from contamination and spoilage. The licensee must store the 5 bags of food off the floor and ensure that all unopened bags of

food are stored compliantly at all times.

Correction date: November 21, 2025

At least 4 open bags of cat food were found in the housing facility. Open bags of food could become contaminated by pests such as insects or rodents.

Open bags of food must be stored in a leakproof container with a tightly fitting lid to protect the food from contamination. The licensee must place the 4 bags of opened food into containers with tightly fitting lids and ensure all open bags of food are stored compliantly at all times.

3.1(f)

Housing facilities, general.

At least 3 trash cans in the housing facility do not have lids. Open trash cans could attract pests such as insects and rodents which could have a negative impact on the health of the cats.

Trash containers in housing facilities and food storage and preparation areas must be leakproof and have tightly fitted lids. The licensee must add tightly fitting lids to each trash can and ensure they remain on the cans at all times.

3.6(b)(4)

Primary enclosures.

One enclosure, containing 1 adult cat and 3 kittens, does not have an elevated resting surface. Elevated resting surfaces allow a cat to exhibit its normal behaviors of jumping and/or climbing and permits a cat space to move away from other cats.

Each primary enclosure housing cats must contain an elevated resting surface. The licensee must add an elevated resting surface to the enclosure and ensure each enclosure contains a compliant elevated resting surface(s) at all times.
