ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

* One adult gray and white male named Darla (number 04-1) and one adult blue and white male named Bandit (number 507) were observed to have an abnormal, goose step appearing gait. The licensee stated that both Shih Zue / Bichon cross dogs were approximately two years in age. When walking no bend or flex to the back legs of both dogs were observed. In addition, the back legs of both dogs would extend straight forward and outwards when attempting to walk. Each dog would elevate one of their back legs and place no weight on it when they stopped walking. When resting the elevated back leg would extend forward to an estimated 45 degree angle and stay that way until they started walking. The licensee stated that both dogs were born with this abnormal gait from a powder she applied to both dogs dams. The attending veterinarian had not been consulted nor had any treatment been provided at the time of inspection. Foot problems can be painful causing discomfort when the dog has to place weight on the affected foot. It can affect the mobility and daily activity of this dog. The licensee must have both animals examined by a veterinarian and appropriate treatment plan administrated. The outcome of this examination must be documented and provided to the inspector upon request. The licensee must ensure that all animals receive adequate veterinary care at all times. Correct by 6/2/16.

3.1(c)(1)(2)

HOUSING FACILITIES, GENERAL.

* A sheet of tin with a horizontal tear estimated to be four inches in length was observed along the lower right hand of one enclosure. The tear was jagged and sharp in appearance and was turned outwards towards the dogs. Three dogs are in contact with the affected area which is located on the west outside wall of the east sheltered building. Jagged edges with sharp points could cause potential injury. The licensee must ensure all surfaces are free of any jagged edges or sharp points that might injure the animals. Correct by 6/2/16.

3.1(c)(3)

HOUSING FACILITIES, GENERAL.

* There is a mixture of dirt, grease and other excreta accumulating on the primary enclosure wall board in two enclosures. Two dogs are in contact with the affected wall boards located in sheltered housing. The affected area covers approximately 30 to 40 percent of the total wall surface. It indicates an unsanitary living condition exists that could lead to a potential disease or health risks. Spot cleaning affected surfaces daily and sanitization of all surfaces is necessary to prevent an accumulation of excreta and other disease hazards. The licensee must ensure that all surfaces are spot-cleaned daily and sanitized at least once every two weeks or more often if needed in accordance with section 3.11 B to help prevent an accumulation of excreta and reduce disease hazards. Correct by 5/25/16.

3.4(b)(2)

OUTDOOR HOUSING FACILITIES.

* The outdoor housing being provided for two dogs consists of a pet carrier. The holes along the sides do not restrict the wind, rain or snow from entering the enclosure. In addition, the outdoor sheltered housing must be large enough to allow each animal to sit, stand, and lie in a normal manner and to turn about freely. Pet carriers are not considered to be acceptable permanent housing for the dogs. The pet carrier intended use is to house dogs or puppies during transport from facility to an ending destination. The licensee shall provide the dogs with adequate housing that will protect the dogs from the direct rays of the sun and the direct effects of the wind, rain or snow. Correct by 6/2/16.

3.11(a)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

* An excessive amount of excreta was observed collecting on the dirt ground floor in one enclosure. Two dogs are in contact with the affected area located in outdoor housing. Excreta is covering an estimated 25 to 30 percent of the available floor area. The licensee stated that approximately a month ago, excreta was removed from the enclosure. This indicates the dogs are living in unsanitary living conditions. The licensee must ensure that all

excreta is removed from primary enclosures on a daily basis. This will help to prevent an accumulation of feces, potential soiling of the dogs contained in the primary enclosure and will help to reduce disease hazards, insects, pests and odors. Correct by 5/25/16.

3.11(c) REPEAT

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

* An overgrowth of weeds was observed collecting next to the west outdoor enclosure run fencing. The fencing is attached to the west sheltered building housing four dogs. The weeds were estimated to be four to five feet in height. This could provide a living area for rodents, other pests or vermin. The licensee must ensure that all weeds must be controlled so as to facilitate cleaning of the premise and pest control and to protect the health and well-being of the animals.

* Shredded paper and rodent droppings were observed collecting on the interior floor area of the west sheltered building housing four dogs. This indicates a breeding and living area exists for rodents, pests and other vermin that could impact the health of the dogs. The licensee must ensure that premises must be kept free of accumulations of trash, junk, waste products and discarded matter. In addition, the licensee must facilitate the husbandry practices require to reduce or eliminate breeding and living areas for rodents, other pests and vermin.

* The facility inspection and verbal exit briefing done on 5/19/16 and the exit briefing done on 5/24/16 were conducted with the licensee.
