* At the exotic animal auction in Columbus, Ne., on the 20-September-2025, you had two Coati Mundis consigned in the auction that were housed in a medium taxi carrier. This taxi carrier had a metal round feed receptacle. This receptacles' metal surface was excessively rusty and corroding. As result of this excessive corroded rusty surface, indicates adequate measures are not being taken to minimize contamination and deterioration of food. Therefore this can increase the disease hazards for the two animals.

For the prevention of diseases and contaminated food, adequate measures must be taken for feed receptacles to be free of corrosion that prevents proper cleaning and sanitization.

* At the exotic animal auction in Columbus, Ne., on the 20th of September, there was two Coati Mundis housed in a medium taxi carrier you had consigned at the sale. This taxi carrier had an excessively rusty and corroded round metal water receptacle. The excessively corroded surface prevents the receptacle for being properly cleaned and sanitized, therefore increasing the disease hazards and minimizing the health for the two animals.

For the health and the prevention of disease hazards, all watering receptacles must be maintained and or free of corrosion that prevents cleaning and sanitation.

inch) in height and with arrows identifying the correct upright position. Without these markings on the primary transport enclosures this can allow for the animals to be mishandled while in transport during movements, Therefore potentially effecting the health and well-being of the animals.

All transport enclosures must be clearly marked with either "Live Animals" and or "Wild Animals" on the top and one or more sides with letters at least (1 inch) in height, and with arrows pointing in the upright position. This will prevent improper handling of the animals in transport and ensure their health and well-being.
