Inspection Report

At least 50% of the cages housing the sugar gliders have excessive amounts of rust. Excessive rust can compromise the structural strength of the cages and does not allow for adequate cleaning and sanitation, which can increase disease risks for the animals. Per the regulations, the facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals. Correct by 30April2023.
