A Tahr goat was observed to be lame during inspection. The goat carried the front left leg when running but was able to use the limb when standing still. The licensee had not observed the lameness until this inspection. The licensee contacted the attending veterinarian (AV) during the inspection and a treatment plan was implemented. Per the regulations, each dealer or exhibitor shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.
