##### Housing facilities, general.

The enclosure for the capuchin has accumulations of excreta and other waste material attracting flies and insects, potentially increasing the risk of disease hazard. The enclosure requires more frequent cleaning to minimize accumulations of waste material to minimize and protect the capuchin from contamination and pests. Correct by May 29, 2021.

#### 3.75(e)

##### Housing facilities, general.

The refrigerator containing the food items for the primates has dead insects and spillage on the bottom shelf. Food items may become contaminated if they come in contact. The refrigerator shall be cleaned to protect food items from contamination. Correct by May 29, 2021.

#### 3.80(a)(2)(ii)

##### Primary enclosures.

The hardware cloth applied at the front entrance to the capuchin enclosure as a secondary barrier to prevent the capuchin from accessing the heat lamp and to protect the workers from the reach of the capuchin when entering the area has a cut out area with sharp points on the edges. These edges are within reach for the capuchin and can cause injury if grabbed
