The formal arrangements between the facility and its AV must include a written PVC and regularly scheduled visits to the facility's premises. In order to ensure adequate veterinary care for regulated animals, the facility must find/update/create its PVC, and have it available for USDA inspection at all times.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

A female ring-tailed lemur was observed with a reddened/hairless lesion at the upper area of the base of its tail; lemur was constantly scratching/biting the affected area. Each dealer/exhibitor must establish and maintain a program of adequate veterinary care (PVC) that include the use of appropriate methods to quickly prevent, control, diagnose, and treat diseases and injuries. Also, the PVC must address daily observation of all animals, in order to assess their health, injuries and their well-being at all times. The facility must contact their attending veterinarian immediately in order to diagnose the condition and to provided treatment to the lemur.
