HOUSING FACILITIES, GENERAL.

The enclosure housing a single macaque has several holes dug out around the perimeter that may allow the macaque to escape or unwanted animals to enter. The ground foundation around the perimeter must be improved and maintained to secure the enclosure and to ensure the animal is safely contained.

HOUSING FACILITIES, GENERAL.

The nonhuman primate enclosures had accumulations of fecal material on the dirt floors and the wooden resting shelves. Contact with excreta may expose the nonhuman primates to disease hazards and attract unwanted pests and vermin. Surfaces that come in contact with nonhuman primates must be spot-cleaned daily and sanitized in accordance with Sec. 3.84 of this subpart to prevent accumulation of excreta or disease hazards. Floors made of dirt, and planted enclosures must be raked or spot-cleaned with sufficient frequency to ensure all animals the freedom to avoid contact with excreta. All surfaces of housing facilities must be cleaned and sanitized when necessary to satisfy generally accepted husbandry standards and practices.

FACILITIES, GENERAL.

There is a large gap dug in the dirt floor under the corner of the door for the coatimundi which may allow the coatimundi to escape or unwanted animals to enter which could expose the animal to injury or death. Indoor and outdoor housing facilities must be structurally sound and be maintained in good repair to protect the animals from injury and to contain the animals.

FEEDING.

Food was observed mixed with excreta on the wooden resting shelf in the coatimundi enclosure. Consuming contaminated food may cause the animals to become ill. Food must be free from contamination to prevent the possibility of the animals ingesting contaminants and becoming ill. Food must be provided in a way to prevent it from becoming contaminated.

Correct immediately.

WATERING.

The water receptacles for the woodchucks and the whitetail deer are rusty and contained dirt and debris. Rusty surfaces cannot be adequately sanitized. All water receptacles must be kept clean and sanitary. In order to prevent health issues clean water must be provided for the animals.

Correct by March 5, 2014.

3.131(a)

SANITATION.

Multiple animal enclosures had accumulations of feces on the dirt floors, in the corners, around the perimeter and on platforms,(raccoons, fox, coatimundi, and skunk) . Accumulations of excreta may attract unwanted pests and may expose the animals to disease hazards. Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals and to minimize disease hazards.
