In the feed room, there were several expired medications. Multiple medications were expired for greater than 5 years.

There were expired Albon (expired 1/2017), Bactricillin (expired 12/2022), Ivomec (expired 5/2021), compounded metronidazole (expired 5/2022), Albon (expired 4/2019), Metronidazole (12/2019), Baytril injectable (2/2015), and Gentavet spray (11/2018) on hand. Medications must be administered within date to provide the appropriate response and to protect the animals from disease. Facility must ensure medications administered are not expired.

Facility disposed of all expired medication during the inspection.

This inspection and exit interview were conducted with a facility representative.
