The licensee shall make, keep, and maintain records or forms which fully and correctly disclose information concerning animals that were purchased or otherwise acquired, owned, held, leased, donated or otherwise in his or her possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by that dealer. The records shall include any offspring born of any animal while in his or her possession or under his or her control. The Record of Animals on Hand (APHIS Form 7019) and Record of Acquisition, Disposition, or Transport of Animals (APHIS Form 7020) are forms which may be used by the licensee to keep and maintain the information required by federal regulations. As required by federal regulations, the licensee needs to obtain/document the pertinent information on the missing transactions of the regulated animals identified above.

FACILITIES, GENERAL.

Excessive rust and paint chipping were observed at multiple areas on four (4) of the seven (7) sugar glider's primary enclosures/cages. Indoor housing facilities for regulated species must be maintained in good repair to protect the animals from ingesting contaminants, physical injury and potential health problems. All surfaces in a primary enclosure must be maintained in good repair as part of a regular, ongoing maintenance program. The affected areas observed should be immediately repaired/replaced/maintained to ensure the best welfare of the animals at the facility.
