The licensee stated that his attending veterinarian resides in Texas and he does not have any formal written arrangements with a local licensed veterinarian who can provide immediate or emergency care if an animal should become ill, as well as the routine visits that the regulations require.

The licensee maintains an uncommon species of mammal which would require a veterinarian with a highly specialized knowledge in its' medical care, behaviors, & husbandry requirements.

You must locate a locally licensed veterinarian with this specialized knowledge in your species of mammal who can provide immediate, emergency, weekend, & routine care under a written formalized arrangement to assure that any ill or injured animal receives prompt veterinary care & treatments to alleviate pain & suffering.
