On August 19, 2021, a member of the public entered an area housing a young skunk. There were no employees or attendants present at the time. The member of the public reached into a 75-gallon glass tank to pet the skunk and was bitten on the hand.

People who are bitten by animals may suffer from pain, discomfort, or infection. Animals who bite humans may be injured
