Primary enclosures.

The upstairs breeding enclosures for Syrian hamsters are not providing the minimum required interior height of six inches. The enclosures are plastic bins measuring less than 4.5 inches tall from the outside.

Not providing the minimum height does not allow for adequate freedom of movement which can which can lead to inadequate exercise, discomfort, stress, and incompatibility. All hamsters must be provided at least the minimum required height (6 inches) in their primary enclosure.

3.31(b)

Sanitation.

The facility does not have adequate housekeeping for the premises which houses guinea pigs and hamsters. There are currently numerous sections of deteriorating insulation hanging from the walls and ceiling. According to the facility representative, insulation often falls from the ceiling onto and into animal enclosures. In the storage area upstairs, there are excessive accumulations of bedding and rodent droppings covering the floor.

Insulation can cause illness or injury to the animals. Accumulations of trash or debris can attract pests and pose disease hazards to the regulated animals. Premises (buildings and grounds) shall be kept clean and in good repair in order to protect the animals from injury and to facilitate the prescribed husbandry practices set forth in this subpart. Premises shall remain free of accumulations of trash.

Sanitation.

The facility does not have adequate housekeeping for the premises which houses hedgehogs, degus, gerbils, chinchillas, a pygmy squirrel. There are currently numerous sections of deteriorating insulation hanging from the walls and ceiling. According to the facility representative, insulation often falls from the ceiling onto and into animal enclosures. At the time of inspection, there is a chunk of insulation on top of the chinchilla enclosure and the degu enclosure where the animals can access it. In the storage area upstairs, there are excessive accumulations of bedding and rodent droppings covering the floor.

Insulation can cause illness or injury to the animals. Accumulations of trash or debris can attract pests and pose disease hazards to the regulated animals. Premises (buildings and grounds) shall be kept clean and in good repair in order to protect the animals from injury and to facilitate the prescribed husbandry practices set forth in this subpart. Premises shall remain free of accumulations of trash.

3.131(d)

Sanitation.

Upstairs in the breeding area, there is an excessive accumulation of rodent droppings. These affected areas house degus, gerbils, and chinchillas. According to the facility representative, there has been an ongoing issue with wild rats at the store. These issues include chewing through the insulation lining the ceiling and walls as well as chewing through bags of feed kept in the store.

Pests such as rats can spread disease and contaminate food, surfaces, and animal housing areas. A safe and effective program for the control of insects, ectoparasites, and avian and mammalian pests shall be established and maintained. To be corrected by September 24, 2025.
