Some dogs were found during this inspection with severe dental disease. The licensee has no documentation that this dogs were identified with dental disease or was scheduled to be seen for this problem.

The licensee must follow the dental care plan as written. The licensee must evaluate each dog's mouth and determine the severity of the dental disease. This must be documented so a schedule can be implemented to have all dogs treated as needed. Correct this by following the written dental care plan.

Dachshund microchip#: Avid 012*811* 634 This dog lost all the front teeth and most of the upper premolars, also has an excessive amount of brown matter on his teeth, and reddened and bleeding gums.

Cavalier microchip#: 0A01122538 This dog lost all the upper front teeth and most of the premolars, also has an excessive amount of brown matter on his teeth, and also the gum line is inflamed and red with several areas where has started to recede.

Cavalier microchip#: 0A1123702 This dog lost all the front teeth and most of the premolars, also has an excessive amount of brown matter on his teeth, and reddened and receding gums.

Shih-tzu microchip#: 0A01122404 has an excessive accumulation of brown matter on his teeth, with a white

Boston Terrier microchip#: 0A01767075 This dog have a heavy accumulation of brown matter in the teeth and the gun lines are red and slightly swollen.

Dental problems are painful and do not allow the animals to be able to feed comfortably also they are a source of infection for other body systems.

Some dogs were found during this inspection with severe dental disease. The licensee has no documentation that this dogs were identified with dental disease or was scheduled to be seen for this problem.

The licensee must follow the dental care plan as written. The licensee must evaluate each dog's mouth and determine the severity of the dental disease. This must be documented so a schedule can be implemented to have all dogs treated as needed. Correct this by following the written dental care plan.

Cocker Spaniel microchip#: 0A01750705 was observed to have bilateral Cherry eyes with an white ocular discharge and profuse lacrimation.

Cocker Spaniel microchip#: 0A01771030 was observed to have bilateral Cherry eyes and white ocular discharge and abundant tearing.

Although this facility has a protocol for cherry eye approved by the veterinarian this is not being followed, because these animals have an active cherry eye with discharge after the initial treatment, (this can be a sign of infection or inflammation) and it has not consulted with the Attending Veterinarian as recommended by the protocol.

Dachshund microchip#: Avid 012*811* 634 was observed to have hair loss in both ears, tail and rear legs. The skin was dry and thickened, in the tail and the legs. No information was found about treatment or consultation with the veterinarian about the condition in this dog.

Boston Terrier microchip#: 0A01767075 was observed to have a big white spot in the left eye, The last treatment of this dog was in May/2014 and there is no follow-up with the veterinary consultation as recommended in PVC.

These dogs needs to be seen by the attending veterinarian. Documentation of the diagnoses, recommended treatments, and treatment of the dogs must be maintained.

Most of the dogs were found with excessive long toenails. Excessive Long toenails can deform the toes and can be easily get caught and tear and injure the dogs. It is important to include an assessment of the length of the nails to the daily observation of all animals to ensure the health and safety of the dogs.

The long toenails need to be trimmed.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

There are multiple animals at the facility that have veterinary care issues. These health problems of these animals were not observed or identified before the time of inspection. The daily observation of the animals can be conducted by the veterinarian or by the licensee, as long as any changes in animal health are communicated to the veterinarian.

The failure to observe the animals daily can lead to health problems that are not identified or treated in a timely manner. Untreated health problems can affect the health and well-being of the animals.

The licensee must observe each animal on a daily basis. If changes in animal health are noticed, these changes should be documented and must be treated by following the PVC. If the PVC does not describe the treatment for the specific condition, the veterinarian needs to be consulted so that the health conditions can be diagnosed and a treatment plan started if necessary.

Records of sick or injured animals should be kept and must be available to Aphis officials at the time of the inspection.
