ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Female Yorkie with microchip #: 0A01565418 has discharge from her left eye. Thick, green material has accumulated in the eye and dried on the hair around her eye. There is also an accumulation of material around her left nostril. Eye problems cause discomfort and pain.

White female Havanese with microchip #: 0A01566835 has hair loss on her lower back and sides. There are two approximately quarter sized spots on her back that appear scabbed. She has been treated for hot spots in the past, but has not been treated recently. Skin problems may lead to deeper infection and further health complications.

Boston terrier Microchip #: 0A01515571 was observed with advanced receding gums especially on the left upper premolar where the root is exposed.

Dachshund #: 0A01566207 has an excessive amount of brown matter on its teeth, and also the gum line is inflamed and red with several areas where it has started to recede.

Some dogs were found during this inspection with various levels of dental disease. The licensee has no documentation that these dogs were previously identified or scheduled for veterinary treatment.

Appropriate methods to prevent, control, diagnose, and treat diseases and injuries must be utilized. The dogs listed

above must be examined by a licensed veterinarian. Documentation of the veterinarian's assessment, treatment, and plan must be maintained for examination by APHIS officials. All veterinary recommendations must be followed precisely and in a timely manner.
