#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

French Bulldog microchip# AVID 051 309 287 was observed with a vaginal prolapse (a red tissue protruding from the vulva). The prolapse tissue looks dry and dirty with the area between the tail and the vulva full of accumulated dried blood mixed with hair and debris, also fresh blood was observed on the legs and on the floor around this dog. This condition puts this animal at risk to have an infection and the tissue is at risk of been injured and/or suffering necrosis, in addition to the fact that this condition is uncomfortable and painful for the animal.

Licensee stated that the condition is about 2 week old and the Attending Veterinarians recommended keeping the area clean and moist until the hormones go down and the condition is resolved.

The condition of this dog at the time of the inspection indicates that the AV recommendation has not been followed entirely.

Failure to follow the instructions of the veterinarian can lead to further pain and suffering. Licensee shall follow all instructions of the veterinarian to ensure that the animal is receiving adequate veterinary care.

necessary manpower that needs to be employed to do this, another type of treatment may need to be taken to prevent the unnecessary extension of the condition and the risk of infection and necrosis in this case.

Despite the fact that this animal was seen by the veterinarian approx. 48 hours ago, the veterinarian may not be familiar with the condition of the vaginal tissue due to the neglect of treatment. The tissue of the vagina looks dry, with some evidence of scabbing.

Failure to provide adequate follow up to ensure a successful resolution of the condition may lead to a prolonged time of suffering for this animal.

This dog needs to be seen by the attending veterinarian. Documentation of the diagnosis, recommended treatment and treatment of the dog must be maintained.
