Attending veterinarian and adequate veterinary care (dealers and exhibitors).

There is a male Boston Terrier named 'Skeeter' (last 4 microchip digits 0251) with a dry, hacking, non-productive cough but otherwise was active and with no nasal discharge. The licensee suspected irritation due to the kennel cleaning solution and decided to switch brands; however the veterinarian was not contacted for diagnosis and treatment recommendations.

There is a female Boston Terrier named 'Poppy' (last four microchip digits 0305) with a red swelling in the corner of the right eye with no tearing or squinting noticed. The veterinarian has not yet been informed of this swelling at the time of the inspection.

There is a female Boston Terrier named 'Sierra' with very mild cloudiness in the center of both eyes (left worse than right), and redness around the eye. In the center of the cloudiness, a slight depression was visible on the surface of the eye. There was no squinting or discharge. The licensee noticed the cloudiness and began treating the eye with ophthalmic antibiotics, but not at the direction of the attending veterinarian.

Inspection Report
