Primary enclosures used to transport live animals.

On Saturday mid-morning 9/8/23 the inspector found a hedgehog curled up on the floor behind an enclosure housing guinea pigs. The adult hedgehog (consignment tag 1752) had escaped from its transport enclosure that had been placed on the shelf above and opposite the guinea pig enclosure. The shelf is about 2 feet off the ground. The lid of the enclosure was not tight fitting and tape was seen on the lid/enclosure. The warm room staff stated that this was the second time this hedgehog had escaped the enclosure by pushing up against the enclosure lid. The hedgehog appeared unharmed at the time it was placed back into the enclosure. Animals that escape from their enclosures may injure themselves during the process and may not be able to be recovered.

Primary enclosures used to transport live animals shall be constructed in such a manner that the structural strength of the enclosure is sufficient to contain the live animal. Correct by end of day 9/8/23.

3.36(e)(1)(i)

Primary enclosures used to transport live guinea pigs and hamsters.

Two guinea pig transport housing enclosures did not provide enough interior height for the guinea pigs. Guinea pig enclosure 1792 housed one male guinea pig and Guinea pig enclosure 1793 housed one female guinea pig. Both enclosures provided less than 6 inches of interior height. The label stated that the height was 5 7/8 inches. Measuring the interior height with a ruler and taking into account the shavings, the interior height provided was five inches. The guinea pigs required 7 inches of interior height. The backs of both guinea pigs touched the inside top of the lid of the enclosures. Lack of sufficient interior height means that the guinea pigs cannot make normal postural adjustments.

The interior height of primary enclosures used to transport live guinea pigs weighing up to 500 grams shall be at least 6 inches and the interior height of primary enclosures used to transport live guinea pigs weighing over 500 grams shall be at least 7 inches. Correct by 9/10/23.

This inspection and exit interview were conducted with the licensee and other facility representatives.
