Attending veterinarian and adequate veterinary care (dealers and exhibitors).

On March 7, 2025, at approx. 12:15 PM, a young aoudad (Lot # 2409) was observed by inspectors in its holding pen as laying down with head up and alert to surroundings. When it attempted to rise from the ground, it was unable to move it's hind end into a standing position and continued to lay on the ground with the legs stretched out from the body. At the time of observation by the inspectors, the facility was not aware of this animal's condition. Subsequently the auction notified the Attending Veterinarian (AV) via text. The AV responded via text at 2 PM and prescribed pain relief until their arrival at the facility. The AV arrived at the facility at approx. 7:50 PM and elected humane euthanasia due to the severity of the injury (diagnosed as a broken left rear leg and a broken back).

Identification of the issue, emergency care, and diagnosis of the downed animal's condition were not provided in a timely manner which led to the prolonged suffering of the animal.

Each dealer or exhibitor shall establish and maintain programs of adequate veterinary care that include: The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.

Handling of animals.

During inspection on March 6 and 7, 2025, numerous members of the public were observed walking through the barns and walkways between holding pens, reaching through the primary enclosures and touching many species of animals waiting to be auctioned or already auctioned.

- On March 6 and 7, 2025, numerous members of the public were observed walking throughout the auction grounds. Insufficient numbers of auction personnel and/or inadequate public barriers allowed the public to reach the animals, including a variety of hoofstock, like sheep, goats, nilgai, eland, camels, llamas and alpacas. Several children and adults were observed reaching through the holding pens to touch the animals. There were no auction personnel
