Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The warm room staff did not conduct an adequate daily observation of 13 spiny mice that were accepted for consignment the morning of December 3rd, 2022. During their afternoon inspection on December 3rd, USDA inspectors identified one spiny mouse with a dried open injury over its right neck. The injury seemed to penetrate the thickness of the skin. The warm room staff did not identify this injury and did not report it to the attending veterinarian. Deep wounds are painful and may easily become infected. Effective daily observation of all animals to assess their health and well-being must be conducted, including a mechanism of direct and frequent communication so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian. After USDA Inspectors mentioned the animal to the AV, the AV identified the wound as an old injury and did not recommend any further treatment.

Procurement of dogs, cats, and other animals; dealers.

A records review of the August 2022 auction revealed JD consigned animals without a valid USDA license. Consignor B898 sold one female raccoon and one male Muntjac without a valid USDA license. No one time exemption was noted on

file. No dealer or exhibitor shall knowingly obtain any dog, cat, or other animal from any person who is required to be licensed but who does not hold a current, valid, and unsuspended license. Correct prior to the next auction.

3.87(a)(3)

Primary enclosures used to transport nonhuman primates.

The transport enclosures for 7 common marmosets and 1 red handed tamarin did not securely contain them within their enclosures. Three of the enclosures were handcrafted transport cages with metal wire spaced 0.5 inches wide. Three enclosures were bird cages with black metal wire spaced 0.5 inches wide. The openings between the wires of the transport cages were large enough to allow the nonhuman primates' forearms to reach out and grasp the USDA inspector's shoelace and pen. Openings large enough for the non-human primates to extend parts of its body through can lead to injury to the non-human primates or to other animals/people nearby. The nonhuman primate shall at all times be securely contained within the enclosure such that it cannot put any part of its body outside the enclosure.

Primary enclosures used to transport nonhuman primates.

Three primary transport enclosures housing 3 common marmosets did not have solid, leak proof bottoms. The transport cages were constructed of metal wires all around, and absorbent puppy pads had been placed on the bottom of the cages along with blankets. Primary transport enclosures should be leak-proof to prevent urine and feces from seeping outside of the enclosure and to prevent the animals from being excessively soiled. Transport enclosures that prevent the leakage of bodily fluids must be used for all future animal transport to keep the animals as clean and dry as possible while in transit.

Inspection Report

The metal support system for the barn's roof has several areas in need of repair. There are areas of the metal beams that have severe rust damage and are missing sections of the beam. These defects may impact strength of the supports. The outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.

The records review for the September 2022 auction was conducted on November 30th. The facility inspection and exit interview took place December 2nd-3rd. They were conducted with the auction manager, Attending Veterinarian and facility staff.
