Access and inspection of records and property; submission of itineraries.

The facility's records required to be kept by the Animal Welfare Act, including the written program of veterinary care and the contingency plan, were not able to be examined today. The licensee states he had given them to his veterinarian after the previous inspection (completed 9/6/22) for review and updating by the attending veterinarian. The licensee has not followed up with the vet to have them returned to the facility. Records required by the Act must be kept available for review by APHIS officials during business hours in order to allow for compliance inspections and to guide the licensee in the care of the facility's animals. The licensee shall have records required by the Act available to allow APHIS officials to examine the records. Correct by 3/31/23.

3.75(c)(1)(i)

Housing facilities, general.

The horizontal metal bars of the indoor capuchin enclosures in the back capuchin building are rusty. The capuchins have contact with these bars. The painted coating over the metal has flaked off and the metal has become rusted and rough/pitted on the surface. These rusty surfaces can no longer be adequately cleaned and sanitized and over time the rust will affect the structural strength of the metal. The facility shall maintain all metal surfaces in contact with the nonhuman primates free of excessive rust. Correct by 05/31/23.
