ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*****An adult, female Italian Greyhound, identification number 010-373-597, had a whitish gray and tannish brown material that extended up into the gum line on the right upper cheek teeth. The gum line was reddened and swollen. There was a whitish gray creamy discharge at the gum line of the upper right cheek teeth. The gum line had receded at the right upper canine tooth. There was a reddened area on the gum tissue approximately one-quarter inch above the gum line of the cheek teeth. This reddened area was approximately one-quarter inch wide and extended the length of two cheek teeth.

*****An adult, female Italian Greyhound, identification number 091-014-799, had an abnormal swelling on the dorsal neck above the right shoulder. The swelling was approximately 2 inches by 4 inches and was hard to the touch. There was a scabbed area approximately one inch by one-quarter inch in the middle of the enlarged mass. The skin surrounding the scab was reddened. The owner stated the dog had been in a dog fight two days prior.

The buildup of abnormal material on teeth and reddened, swollen gums can be painful, impact the ability of the dog to eat normally, and harm the health of the animal. The swelling and scabbed over area can be painful and may indicate an underlying disease process. The licensee must have these animals examined by a veterinarian by 5:00 p.m on March 26, 2014, to obtain accurate diagnoses and appropriate treatment plans for the issues cited above. The outcome of this consultation must be provided to the inspector upon request. This documentation should include the veterinary diagnosis, all diagnostic tests and the outcome of those tests that were performed by the veterinarian, any medications prescribed along with the dosing instructions, and entries on a log and/or calendar and/or animal health record that list when the medication is administered to the dog.

There should also be an entry at the end of the treatment to document the health status and condition of the dog at that point, to indicate a time frame to address current issues that require further veterinary treatment, and the need for follow-up and any further veterinary care prescribed.

OUTDOOR HOUSING FACILITIES.

*****There were at least five outdoor shelters housing a total of six animals that did not have adequate bedding. More than 50 percent of the floor of the shelter was not covered with bedding. The overnight temperature was below 40 degrees F and was 49 degrees F at the time of inspection. The lack of dry bedding may decrease the animal's ability to thermoregulate and cause distress and suffering. Dry bedding, a heat source, or other method of conserving body heat must be provided for the animals.
