ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

***An adult male black Italian Greyhound, identification number 0A01575021, had dental problems. The dog had hard lumps on both sides of his face halfway between the corner of the dog's mouth and below his eyes. Upon examination of the dog's mouth, the upper molars were completely encased in a hard grayish-white material that was about the size of a marble, which were causing the lumps that are apparent from the outside. The gum line above all the upper teeth was reddened. The front teeth have a grayish-brown hard material that is adhered to at least 90% of the surface of each tooth. There was a creamy white discharge at the gum line of the upper incisors. The upper canines have a grayish-brown hard material adhered to at least 75% of the surface.

***An adult female blue and gold Yorkshire Terrier, identification number 0A01600159, had dental problems. The upper teeth had a buildup of yellowish-gray hard material adhering to the teeth. The gum line was reddened and there was a whitish creamy discharge above all the upper teeth.

Dental problems can be painful, make it difficult to eat, lead to the development of other health problems, and can affect the well-being of the animal.

The licensee must have these animals examined by a veterinarian by 5:00 p.m. on September 17, 2014, to obtain accurate diagnoses and appropriate treatment plans for the issues cited above. The outcome of this consultation must be provided to the inspector upon request. This documentation should include the veterinary diagnosis, all diagnostic tests and the outcome of those tests that were performed by the veterinarian, any medications prescribed along with the dosing instructions, and entries on a log and/or calendar and/or animal health record that list when the medication is administered to the dogs.

There should also be an entry at the end of the treatment to document the health status and condition of the dog at that point, to indicate a time frame to address current issues that require further veterinary treatment, and the need for follow-up and any further veterinary care prescribed.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

***There were at least two dogs that had excessively long toenails. One adult female white and fawn Italian Greyhound, identification number 010514821, and an adult male black and white Italian Greyhound, identification number 0A01382449, had toenails that curved excessively and caused the toes to rotate unnaturally.

Toenails that are too long can affect the dog's gait, be uncomfortable or painful, and could cause the dog to get its feet caught in the flooring and cause an injury.

The licensee must ensure that toenails are trimmed as needed as part of a program of veterinary care

FEEDING.

***There were at least five food receptacles that were dirty. There was a buildup of dark brownish-gray grime on the food receptacles.

Dirty food receptacles can harbor disease-causing pathogens and affect the health of the animal.

The licensee must ensure that all food receptacles be cleaned and sanitized at least every two weeks, or as often as necessary to ensure the health of the animals.
